Request an Authorization to Test (ATT)

Please note that all Authorizations to Test (ATTs) and exam credits purchased on or after July 1, 2014, will be valid for six months. Any ATTs purchased prior to July 1, 2014, will be valid for 12 months.

To make the testing process easier for all of our candidates, APICS Certified in Production and Inventory Management (CPIM) and APICS Certified Supply Chain Professional (CSCP) exams will be offered exclusively in computer-based testing (CBT) format worldwide as of November 1, 2013. Exams in North America are scheduled with Pearson VUE, and exams outside of North America are scheduled with Prometric.

In order to proceed, all candidates must have an APICS ID number.

Step 1: Verify name and contact information
